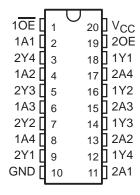

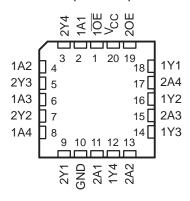

SN54BCT241 . . . FK PACKAGE (TOP VIEW)

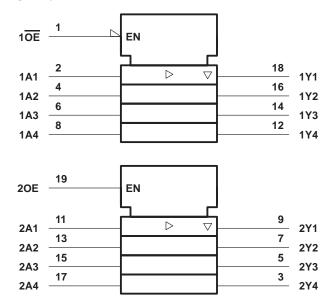

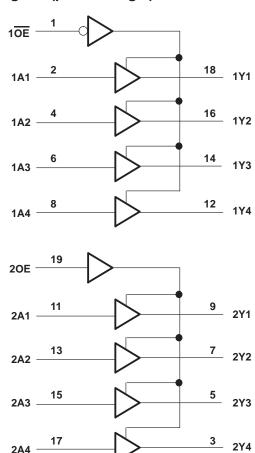
