



The SN74LVC1G0832 is a single 3-input positive AND-OR gate. It performs the Boolean function $Y = (A \bullet B) + C$ in positive logic.

DESCRIPTION/ORDERING INFORMATION (CONTINUED)

By tying one input to GND or V_{CC} , the SN74LVC1G0832 offers two more functions. When C is tied to GND, this device performs as a 2-input AND gate (Y = A \bullet B). When A is tied to VCC, the device works as a 2-input OR gate (Y = B + C). This device also works as a 2-input OR gate when B is tied to VCC (Y = A + C).

NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.


This device is fully specified for partial-power-down applications using I_{off} . The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.




Figure 1. 2-Input AND Gate




Figure 2. 2-Input OR Gate




Figure 3. Y = (A • B) + C



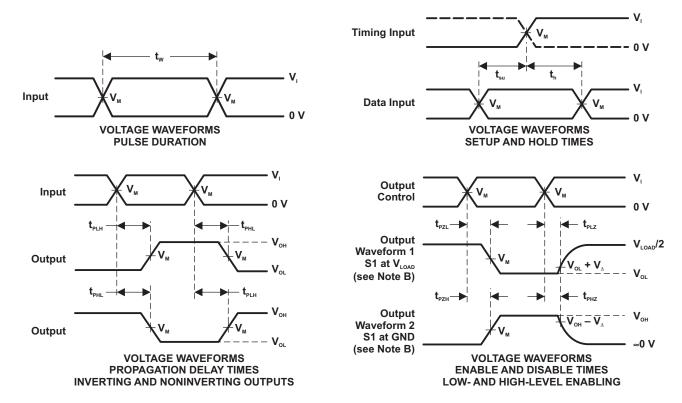



Figure 4. Load Circuit and Voltage Waveforms





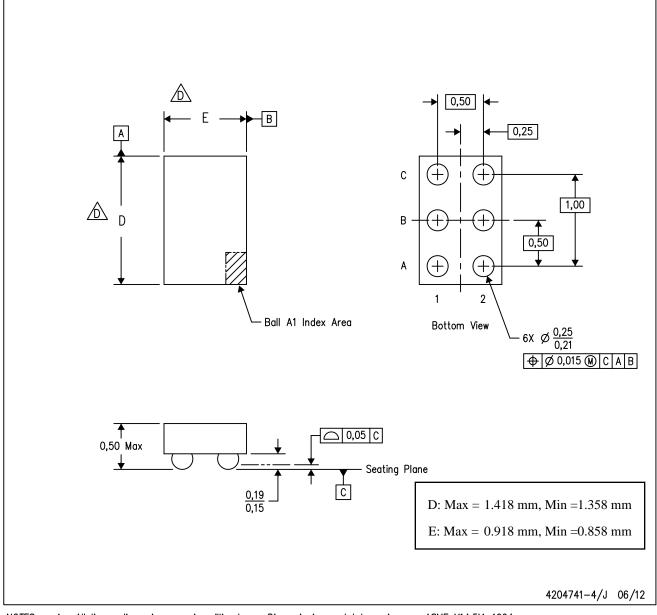
